

4-H Urban Immersion Project September 21st – September 24th, 2023 - Washington D.C

The 4-H Urban Immersion Project (UIP) is an Ohio 4-H initiative that combines cross-cultural learning, teamwork and service learning in the urban environment of Washington, DC. This year marks the 10th anniversary of the UIP Experience!

4-H teens ages 15-18 and still in High School are eligible for this 4-day service-learning experience that will build skills and abilities to prepare youth for success in a diverse workplace as well as build cultural understanding of those who are different. This experience will not be about shopping or sightseeing, although we will visit some monuments and historic sites. The cost of the experience is \$180. Limited scholarship funds are also available. All teen applicants will be contacted to complete an additional phone interview before selection.

- What: 4-H Event Youth Assistant (4HEYA)
- Who: Individuals aged 13-18 (as of January 1 of the year of application) and have at least 1 year prior 4-H experience.
- Timeframe: Apply by May 15, selection, training, service to OSF, and evaluation. Complete responsibilities by August 31, 2023.
 - Applications available at: https://go.osu.edu/4HEYAapp
 - Two references should be submitted at: https://go.osu.edu/4HEYAref
- Requirements (in addition to application/selection process):
 - Training Must attend one of the options for training (July 11 or July 17)
 - Events Must work a minimum of 3 events at the Ohio State Fair; may work more if desired
- Program Fee: \$25/person (paid at go.osu.edu/4HEYA25);
- What about the Teen Leadership Council? YES, these members may apply for 4HEYA AND TLC this year, if desired. TLC applications will be available in June and will be due the Friday following the Ohio State fair. Their term is September 1, 2023-August 31, 2024. Current TLC members are not eligible to apply for 4HEYA, as they are already fulfilling obligations at the Ohio State Fair.

Accommodations: Youth with Special Needs

- 4-H welcomes and encourages youth with special needs to participate and will make reasonable accommodations. The Winning 4-H Plan enables youth to tailor the 4-H experience to their needs and helps maintain a positive relationship between the youth's family, 4-H volunteers, and county 4-H professionals
- Youth must submit a Winning 4-H Plan Request Form by June 14. A county 4-H professional will review the request and contact you with any questions. They will consider whether making accommodations fundamentally alters the event or provides significant advantage or disadvantage to anyone participating. Judges are expected to follow accommodations.
- The completed form needs to be stapled in the front cover of the project book. The 4-H professional will share appropriate information with those who need it.

QA Training Dates

Monday, May 22, 5:30 PM at OSUE Locations will Be Announced

Any youth wishing to exhibit an animal at the fair in 2023 is required to complete Quality Assurance. Quality Assurance for exhibition at the Greene County Fair must be completed by June 1st. Any youth wishing to exhibit at the Ohio State Fair MUST complete Quality Assurance prior to the start of the OSF.

New in 2023! Greene County 4-H will be accepting online QA certificates. The online module completed must be for the correct 4-H age. Only the YQCA courses currently meet ODA standards. BQA, PQA, BEST and other online programs do not meet this requirement. The cost is \$12 per youth. Once complete you will need to download the certificate and email it to Rebecca or Brenda. If you do not download and email you will not be considered complete for 2023. Deadline to submit certificate is June 1! Program details: www.go.osu.edu/gcyqca

All Greene County 4-H Exhibitors need to complete an inperson or online QA before the June 1 deadline. NO EXCEPTIONS WILL BE MADE!

Check your status of Quality Assurance (QA) training by logging into 4HOnline by clicking the training on the left side.

If you will be showing swine at the Ohio State Fair you parent will need to have PQA certification. Please call the office and we will provide name and number of person that can help your parent get that certification.

Birth Rabbit Dates for 2023 Fair

- Meat Pen and Single Fryer = 5/21/2023
- Roasters=01/31/23- 04/30/23 with a maximum weight of 9 pounds, Must be at least 3 months old.

- Fancy D&L = 05/20/23 06/03/22

- 4/21/2023: This is 100 days prior to the show day. Remember that each individual rabbit must weigh between 3.5 and 5.5 pounds. Any under or overweight rabbits will be ineligible for placing in the show.

Leasing of Animals

Greene County 4-H does allow breeding animal/dairy leases. These forms are <u>required</u> to be on file with our office. The deadline to turn these in is May 1, 2023. Examples of leases can be found on our website at: https://greene.osu.edu/program-areas/4-h-youth-development/livestock

These leases are required to be in place by May 1, 2023, and go until the completion of the project.

As a reminder:

Leasing <u>MARKET</u> animals for youth exhibition projects is <u>NOT</u> permitted under any circumstances.

New for 2023

All swine exhibitors will be required to have a Premise ID. This is mandated by Ohio Department of Agriculture. Premise ID is based on the location of the animal. Please note-you must enter the Premise ID when completing Fair Entry and this number will be checked upon fair arrival. Please visit

Hog Pictures – DUE May 15

Pictures: Pictures of secured hogs must be turned into the Extension Office by 4:00 p.m. on May 15, 2023, No Exceptions. Hard copy pictures will only be accepted. NO electronic copies, including but not limited to emailed pictures, faxed pictures, cd-disc pictures, flash-drive pictures, etc. MUST BE PRINTED PICTURES, NO EXCEPTIONS. The pictures must show the ear notches of each pig and the side view of each pig. On the back of the picture please list the exhibitors name, club name and gender of the hog. Please note; if there are multiple siblings and pigs, you are permitted to put all siblings name on the same picture. **The Extension Office has a drop box out front, so the pictures can be dropped off 24 hours a day. **

Don't Forget QA & EquiSTEP (for horse exhibitors) Requirement

All QA and EquiSTEP requirements are due by June 1 at the latest. See details on in person QA and how to complete it online on page 4. EquiSTEP directions are in the last Horse Happenings newsletter sent to all horse exhibitors.

Please note, if QA and/or EquiSTEP is not completed and is a requirement for your project, you will NOT be able to participate at 2023 Greene County Fair.

Rabbit Number Updated

Please note that the rabbit rules have been posted and approved by the Senior Fairboard. There is a new number for Ohio 4-H Rabbit projects for 2023. The rules posted are correct except the new number for rabbit projects is 228. The numbers are:

Purchasing 4-H Market Project Animals

Here are some important points to keep in mind:

All market animals:

- Purchase healthy animals from reputable breeders
- Know what vaccinations and parasite control has been completed by breeder
- Ask the breeder what feed the animal has been on to be able to transition the animals to the feed you want to use
- Quarantine animals purchased if you have any other animals at home.
- Observe purchased animals closely for signs of illness (take temperature, monitor eating/drinking, observe changes)
- Establish a valid VCPR for preventative care and treatment
- Properly handle animals and provide proper care to assure you have a healthy animal to bring to fair. All animals must be free of contagious disease such as ring worm, sore mouth, club lamb fungus, warts, lice, etc.

Market Goats and Lambs:

- ALL market goats and lambs must have a scrapie tag.
 Scrapie tags must come from the breeder of the lamb or goat. Exhibitors will need to enter this prior to tag-in.
- Homegrown forms must be completed and turned in by due date if applicable.

Market Hogs:

- Must be ear notched. Know your pig's ear notches.
 Required to submit pictures.
- Premise ID is required! Make sure you know what your number is when completing entries! NO EXCEPTIONS.

Poultry:

 Turn in market poultry order forms by due date to the fair office.

Rabbit:

- Exhibitors may breed or purchase a meat pen. If purchased, the rabbits must be in possession by July 14. Only 1 meat pen, one single fryer, and one single roaster may be entered.
- This New Roaster class will be a home-grown class and is new for the 2023 fair. For the home-grown class the Rabbit committee will be verifying with pictures of the doe and litter with visible tattoo numbers, pedigrees, and possible home visit. These Roasters will also have a tag in date of April 15. You may bring up to 3 rabbits per exhibitor to this tag in. You will only be exhibiting 1 Roaster at fair.



Club Frequently Asked Questions

(As we have been holding Volunteer Trainings, we have received some questions that we needed to do a little more research on. Below are the questions and answers that we have received. Volunteer trainings have covered finances in depth, and these questions have been asked.)

Q1: Can Cloverbuds hold an officer position?

A1: Clovebuds can NOT hold an officer position. But they can be assistant to an older project age member with their officer position.

Q2: Do we need to keep track of equipment our club or committee holds?

A2: Yes, please complete an equipment log sheet this needs to be turned in with your financial summary each year.

Q3: How long do clubs or committees keep their banking documentation?

A3: Banking documentation including records of deposits, periodic statements of balance, canceled checks (including access to checks imaged under the authority granted in Check21) and reconciliation documentation. Also includes audits, receipts, invoices and packing slips. Current year plus 4. Example: 2023, 2022, 2021, 2020, 2019. Anything prior to year 2019, should be brought to the Extension office. A certificate of records destruction will be filed with the OSU archives prior to destruction on the club/committee behalf. Please make sure to note this in the next club secretary minutes.

Q4: Can we use the same constitution and bylaws in the past?

A4: No, they all must be updated and voted on each year. With the head advisor and current club president signature on them.

Q5: What are committee paperwork requirements?

A5: Each year they need to turn in financial summary, constitution, bylaws, equipment list if needed.

Q6: Organization gave us a gift card. Do we need to record that on your financial summary?

A6: Yes, you will need to record as income on your end of year financial summary.

Q7: My 4-H member needs to add a project after they have been approved?

A7: After your child has been approved by the office in 4Honline. You can go back into their profile and add projects up until the April 1, deadline. *No changes, additions, or deletions will be allowed after the April 1, deadline.*

Q8: Will Greene County 4-H accept a Quality Assurance Certificate (QA) from another county?

A8: Yes, we will accept a certificate from out of county. You will need to bring the certificate into the office so we can make a copy. Credit will not be given until we have certificate in hand. All certificates need to be turned in before the June 1, deadline.
